BAR SOFTBALL LEAGUE

WAIVER

In the spring of 1985 it came to the attention of the Board of Directors of the San Diego County Bar Association that the long-standing practice of requiring bodily injury-occurrence releases and indemnities from participants in Bar-sponsored competitive sports leagues had not, in recent seasons, been properly enforced. The Association provides an organizational structure for voluntary participation sports leagues by members of the Association. It has always been the policy of the Association that individual members participate at their own option and at their own risk. After diligent and lengthy investigation, the Board found that insurance for the risks of sports participation was unavailable. As a matter of the Board's duty of financial responsibility to the Association, the Board has instructed the Sports Committee to obtain the following written acknowledgment of these circumstances from all participants in competitive sports leagues:

RELEASE FROM LIABILITY AND ASSUMPTION OF RISK

The undersigned understands that the City of San Diego, Presidio Little League, other property owners, tenants, and the San Diego County Bar Association are providing the facilities for sports activities sponsored by the San Diego County Bar Association from time-to-time during the year. The undersigned further understands that the Presidio Little League and other property owners and tenants and the San Diego County Bar Association will not accept financial or legal liability for any injury or occurrence arising from sports activities and that accordingly, my participation in such activities must be at my own risk.

ACCORDINGLY, THE UNDERSIGNED HEREBY WAIVES ALL CLAIMS WHICH HE/SHE MIGHT HAVE AGAINST THE PRESIDIO LITTLE LEAGUE, THE CITY OF SAN DIEGO, THE SAN DIEGO COUNTY BAR ASSOCIATION, AND ANY AND ALL OTHER PROVIDER(S) OF FACILITIES, AND/OR ANY OF THEM IN COMBINATION, and their officers, directors, agents, employees, and contractors for injury, accident, illness, property damage, death, or other occurrence arising in any manner whatsoever out of his/her participation in sports activities sponsored by the San Diego County Bar Association.

IN ADDITION, THE UNDERSIGNED HEREBY EXPRESSLY ASSUMES ANY AND ALL RISK(S) of his/her participation, including the risk that he/she might be injured as a result of the negligence or gross negligence of Presidio Little League, any other facility provider, the San Diego County Bar Association, or any of them, or their officers, directors, agents, employees, or contractors, or as a result of a defect in or on the property of any of them. The undersigned hereby agrees to indemnify, save and hold

harmless and defend each and every of the above parties of and from any and all loss, costs, damages, expenses, and attorney's fees arising out of his/her participation in such sports activities.
